Motueka South School (3206) Enrolment Scheme

Effective from 23 August 2019

The guidelines for development and operation of enrolment schemes are issued under section 11G (3) of the Education Act 1989 for the purpose of describing the basis on which the Secretary's powers in relation to enrolment schemes will be exercised.

Home Zone

All students who live within the home zone described below (and shown on the attached map) shall be eligible to enrol at the school.

The Home Zone takes addresses on both sides of the boundary roads mentioned in the description unless otherwise stated.

Starting from the intersection of Glenaven Drive and Motueka Quay, the home zone follows:

- South on Motueka Quay until Old Wharf Road
- West on Old Wharf Road until Trewavas Street
- South on Trewavas Street until Wharf Road
- West on Wharf Road until High Street (SH 60)
- South-west on High Street South until Wildman Road (including Batchelor Ford Road)
- West on Wildman Road until 100 Wildman Road (the boundary with Wildman Park)
- East back along Wildman Road and High Street South until its intersection with High Street (SH 60)
- North on High Street (SH 60) until Old Wharf Road (including Courtney Street)
- West on King Edward Street until Oueen Victoria Street
- West on College Street until the Motueka Valley Highway (including Queen Victoria Street until Green Lane to the north and Hau Road in the south, Marchwood Park Road, Thomason Avenue, and Hau Road)
- South on the Motueka Valley Highway until Alexander Bluff Road (including Stony Ridge Way, Mytton Heights, Pineview Way, Wellspring Place, and Tiamat Way)
- West on Alexander Bluff Road until Motueka River West Bank Road
- North on Motueka River West Bank Road until Shaggery Road
- North-west on Shaggery Road until number 112 Shaggery Road
- From number 112 Shaggery Road travels back along until Motueka River West Bank Road
- South on Motueka River West Bank Road until number 470 Motueka River West Bank Road.
- From number 470 Motueka River West Bank Road jumps east across to the Motueka Valley Highway
- North on the Motueka Valley Highway until College Street
- East on College Street until Queen Victoria Street
- East on King Edward Street until High Street (SH 60)
- North on High Street (SH 60) until Lowe Street

- East on Lowe Street until Woodland Avenue
- South on Woodland Avenue until Sanderlane Drive
- East then south then west on Sanderlane Drive until Monahan Street (including Kakariki Lane and Kakapo Lane)
- West on Monahan Street until Huffam Street
- South on Huffam Street until Old Wharf Road
- East on Old Wharf Road until Thorp Street
- North on Thorp Street until Totara Park Avenue
- East on Totara Park Avenue until Kanuka Place (including Titoki Place and Karo Place)
- South on Kanuka Place until the end of Kanuka Place
- From the end of Kanuka Place jumps south to the end of Claire Place
- From the end of Claire Place travels South on Claire Place until Glenaven Drive
- East on Glenaven Drive until Motueka Quay

Special Programmes

Out of Zone Enrolments

- Secretary. Under Section 11G (1) on the Education Act 1989. Parents will be informed of the date of any ballot by notice in a daily or community newspaper circulating in the area served by the school.

Applicants seeking second or third priority status may be required to give proof of a sibling relationship.
